**Option 1** – Online through Studio Director (This is for all Without Limits – Team Galaxy Members, not just dancers)

1. Go to our Studio Director registration site (<https://app.thestudiodirector.com/withoutlimitsdancecomp/portal.sd>)
2. Create your athlete's profile
3. Choose the Registration option

**Option 2** – Manually paying by cash or check
